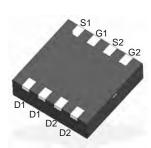

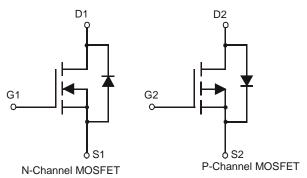

Equivalent Circuit

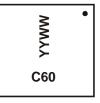

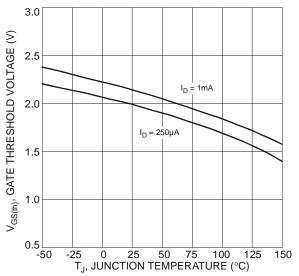
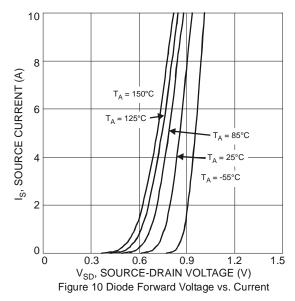
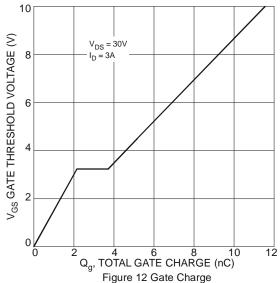
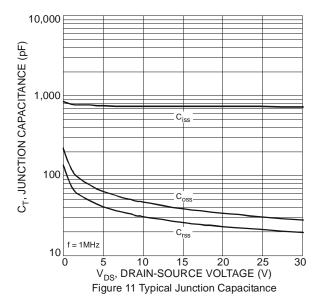


Figure 9 Gate Threshold Variation vs. Ambient Temperature









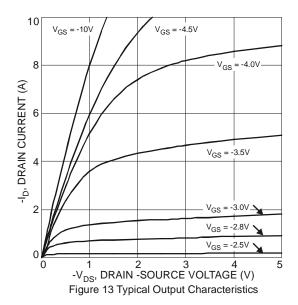


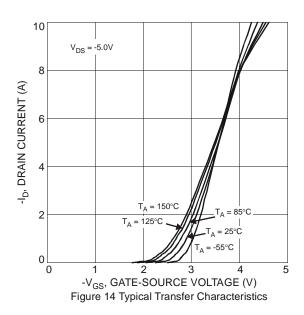

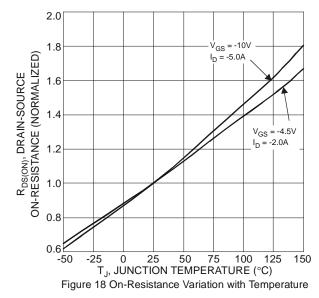












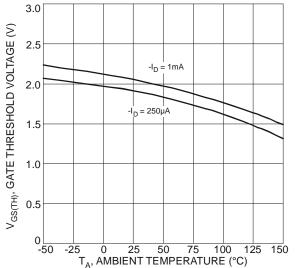


Figure 20 Gate Threshold Variation vs. Ambient Temperature

Figure 19 On-Resistance Variation with Temperature

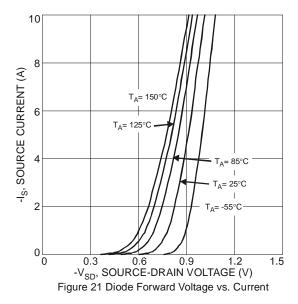
